1. Call to Order - 12:13 PM

Paul Homik welcomed the members and indicated that there was a quorum of at least 20 members present and 3 proxies from Board of Directors, therefore the meeting was duly constituted. Materials for reference were on each table in the Annual Report:

2. Approval of the March 25, 2014 AGM Meeting minutes
