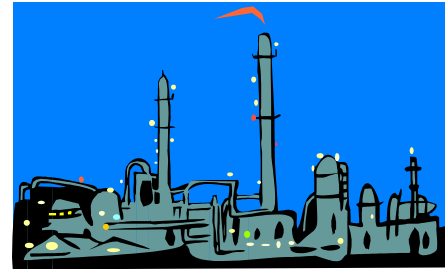

◆ Invoicing / Settlement

- Cost recovery model
 - Charge capital and operating fees to third-parties
 - 13th month adjustment
 - For Joint Ventures
 - Charge excess usage fees to partners
 - Share revenue with partners
 - Annual equalization of expenses and revenues



◆ Invoicing / Settlement

- Take-or-pay model
- Keepwhole or 'Extraction Premium' model
 - Producer or shipper is kept whole on energy (Residue GJs)
 - Producer or shipper may be paid an extraction premium
 - Processor keeps NGLs
- Other models that result in processor taking a position in NGLs and / or Residue
 - Product in lieu of cash fees for processing
 - Processor keeps a portion of NGLs and / or Residue
 - Fixed / Guaranteed recoveries
 - Processor guarantees recovery efficiencies of NGLs
 - Processor keeps incremental recovered volumes

◆ Forecasting

- For long-term budgeting purposes and / or shorter-term estimates / accruals
- Project revenues and margins for processing agreements based on
 - Volume extrapolation (incline / decline curves)
 - Anticipated new sources of volumes and their contract terms
 - Rate escalations
 - Forward Gas and NGL price curves
- Used by major plant operators to set and refine budgets
